 1. We have 5 people who are interested in running for a seat on the executive board. Our constitution and bylaws currently limit membership to three members at large. Tom Annonson proposes that we raise the number to 5. Before this can happen, we need to draft a proposal, have it read at two meetings, send it to the department and then, once approved, to National. This will take almost a year.

The consensus was, however, that we need to do something immediately. So a motion was made by Commander Zimmerman that we recommend that 2 alternates be elected, in addition to the three at large members. These alternates would not have a vote UNLESS another member of the e-board was absent. If one was absent, then the first alternate would have a vote. If two were absent, then both would have a vote. Bruce Tiegen 2nd the vote. Motion was carried. This will be taken to the general membership at the next regular meeting.

 - Motion to change the structure of the executive board was made by Darrel Baltzell. Seconded by Ward Sutton. Motion Carried.
 2. The following proposed changes to the chapter constitution and bylaws was read for the first time:

CONSTITUTION
ARTICLE IV – ADMINISTRATION

 Currently Reads as follows (amended):
 Section 2: The Chapter Executive Committee (See articles 3: page 2 these bylaws) shall be composed of: The Commander, Senior Vice Commander, 1st Junior Vice Commander, Treasurer, Judge Advocate and three (3) other elected Committee members from two-thirds (2/3) of members present. Adjutant for record keeping only, in case of a tie Executive Chairman will vote only to break tie.
Proposed change:
 Section 2: The Chapter Executive Committee (See articles 3: page 2 these bylaws) shall be composed of: The Commander, Senior Vice Commander, 1st Junior Vice Commander, Treasurer, Judge Advocate and three to five other elected Committee members from two-thirds (2/3) of members present. Adjutant for record keeping only, in case of a tie Executive Chairman will vote only to break tie.

- BYLAWS
ARTICLE 3 EXECUTIVE COMMITTEE (CONT.)
- Currently reads as follows (Amended):**
 Section 2: The executive committee shall be composed of eight members (8). Commander, Senior Vice Commander Junior Vice Commander, the Treasurer, Judge Advocate, Adjutant (for record keeping only) and three (3) chapter Executive Committee members, the latter to be elected from Chapter members in good standing, as above provided, and in accordance with "Nominations and Election" and three such committee members shall be elected thereafter at each annual Chapter election. The committee shall elect its own chairman from the membership, who shall not be the commander. None of the three (3) Chapter Executive Committee members shall hold other elective office in this Chapter. The Chairman only votes to break a tie. (This chairman will always assure Chapter Commander is aware of all Executive Committee activity and actions should the commander not be present at a meeting).

- Proposed Changes:**
 Section 2: The executive committee shall be composed of a **minimum** of eight (8) members. Commander, Senior Vice Commander Junior Vice Commander, the Treasurer, Judge Advocate, Adjutant (for record keeping only) and three to five (3-5) chapter Executive Committee members, the latter to be elected from Chapter members in good standing, as above provided, and in accordance with "Nominations and Election" and three such committee members shall be elected thereafter at each annual Chapter election. The committee shall elect its own chairman from the membership, who shall not be the commander. None of the **three to five (3-5)** Chapter Executive Committee members shall hold other elective office in this Chapter. The Chairman only votes to break a tie. (This chairman will always assure Chapter Commander is aware of all Executive Committee activity and actions should the commander not be present at a meeting).
- Currently reads as follows (Amended):**
 Section 10: Any one or more of the three (3) Chapters appointed Executive Committeemen may be removed from office if they miss three unexcused meetings in a row.
Proposed changes: *This is poorly worded, and needs to be changed, both to reflect our proposed executive committee makeup, and because it is vague grammatically incorrect.*
 Section 10: Any one or more of the at-large Executive Committeemen may be removed from office if they miss three meetings in a row. The absences that count towards being removed are **unexcused absences.**

SPRING 2020 NEWSLETTER

We had a great year in 2019 serving 127 veterans and 48 family members. We did have a few hiccups – a blizzard caused us to cancel an ice fishing event, the lodge in South Dakota that we were scheduled to stay at for the pheasant hunt burned in late summer so we ended up making two trips to accommodate all applicants, another blizzard on the 10 of October severely limited the disabled deer hunt on Rydell Refuge. Our “Riley Kuznia Memorial Disabled Veterans Goose Hunt” was well attended and a good number of geese were harvested, this event is memorable in that the Minnesota Dept of Veteran Affairs Commissioner, Larry Herke was here on Friday and Saturday as a volunteer and to observe our operations, he toured our two deer camps and facilities & was out in the field with one of our groups of hunters.



For 2020 we are expanding our deer hunting area to approximately 4000 acres, this will provide more flexibility in the positioning of our blinds and more opportunities for Veterans to harvest a deer. We also plan to request permission again from MN DNR to hunt geese over water during the early season.

January 16th, 2020 MRVO had its' annual meeting, the 2019 finance and event operations reports were read and accepted, the 2020 budget was presented and approved, the bi-annual election of officers was held, and various committees were re-organized. The 2020 fundraising efforts and the planning for this years' events now begins. It is anticipated that we will again do a raffle in cooperation with “Hardware Hank Stores” “Big Buck Contest”. The grants that we have been receiving from V4V (which partially funded operations) are no longer available because there is a three year limit on these, so we will be pursuing other sources of financing for our operations, various VFW, American Legion posts & DAV Chapters as well as MN DAV Foundation have been faithful supporters of our mission of serving veterans and their family members. We continue to receive various amounts of donations from individuals. MRVO is sincerely appreciative of the all the support we receive.

MRVO is planning for 11 or possibly 12 events for 2020 with a goal of serving a total of 180 veterans / family members with outdoor recreation activities.

CHAPLAIN'S CORNER



We started last month looking at hope and healing. Hope, it really helps in so many ways. Regardless of the veteran's or family's situation, hope is such a wonderful sense of true relief. 'When hope is crushed, the heart is crushed, but a wish come true fills you with joy' (Proverbs 13:12 - Good News Translation). There are so many different considerations when it comes to hope. This month we continue looking at hope in its' proper context (true vs. false). So, how does this help a disabled veteran, their family or anyone who were not healed and lost hope without minimizing their condition and experiences. The answer can be found in the purpose for Jesus' coming to earth as seen in the application of this specific issue in Mark 1:32-39. We are looking at issues like, what about veterans who were not healed, does God care about us? Where is the hope (Job 42:11)? Do the people in our life matter? What are some of the misunderstanding out there that can hurt, and cause mistrust in our faith?

The context of Mark 1:32-39, has to do with Jesus being with a very large group of people in the evening who wanted to be healed. At this point Jesus was healing many people. Yet, it is interesting Jesus goes out an prays early in the morning and later tells his disciples it is time to move on while many more people had gathered in the morning to be healed. Again, what about those who were not healed or for that matter what about veterans who were not healed, does God care about us? A person would think that Jesus would want to stay and continue to heal more people, not wanting to leave anyone behind. Jesus as fully God and fully man is full of compassion, therefore moving on did not have anything to do with God being less compassionate. Jesus was not minimizing the condition (disabilities, injuries, sickness, trauma, physical, mental or spiritual) or needs of the people.

Researching and reflecting on one commentary shows Jesus prayer is a prayer being done at a very critical time (as all His prayers in Mark), suggesting it is important to focus at that moment on another critical task given to Jesus, which meant to move throughout other towns to share the good news of salvation. Jesus already being there and healing the people is an introduction of salvation being exemplified, while Jesus did not want to be seen simply as a miracle healer. Yes, healing is very personal because it really does lift a tremendous burden off, while giving us hope, and at the same time Jesus mentions elsewhere the importance of sin and if a part of your body (that was, or needs healing) causes you to sin, cut it off (Mark 9:43). Keeping this in context, Jesus is addressing, and differencing the reality of healing, sin and salvation, something Joni Earickson Tada points out <https://www.youtube.com/watch?v=2TevDhFzjI4>. Jesus wants us to be whole and there is so many people who are genuinely healed, while at the same time there are many who are not, so where is the hope (Job 42:11)?

On a more personal note, Job experienced a lot of trauma, yet in the end, God restored him in so many ways, including the people Job needed to help him heal. This is something that is so important for us as we continue to live with our disabilities, or transition into the healing God has given, yet in either way, God's promise for a total restoration in the future is a promise that is a blessing and gives us hope. So the people in our lives can really help restore a sense of hope. This may be through the Department of Veteran Affairs, good personal relationships, and veteran organizations.

We will look at some of the misunderstandings that can hurt, and cause mistrust in our faith next month.

VETERANS DAY ON THE HILL 2020

I am happy to announce we are currently scheduled to have Veterans Day on the Hill (VDOTH) 2020 on April 20th, 2020. I am well aware this is the latest date to hold the event since I have been involved with the planning, and I want to assure the setting of a date was not without reasons. This is the session leading up to an election, I fully suspect that the pace will go something like this: Initial committee work, two months of issues based politicking to appeal to elected official's base, final weeks to complete the work necessary and govern.

The later date is partially based on my belief that the combined efforts of the Veteran's community can push our supported legislation through the first couple of stops in the committee process which is the first part of how I suspect the session will go.

Historically, interest in the process has been high early on when the path for bills is relatively predictable; original committee, subsequent committee, etc. with regularly scheduled committee hearings. However, once the process starts to "breakdown" into legislation being "held over for possible inclusion", entire bills become small parts of a 'monster' omnibus bill, etc. it becomes hard to explain the process, difficult to coordinate responses, and our advocacy suffers as a result at the most important times. A later date will allow for a clear statement of current position in the most confusing part of the process.

We can focus our advocacy on the bills that actually have a chance. It's harsh to say, but many of our groups will support many pieces of legislation but the honest truth is very few of them have a chance based on the priorities set during the session.

As a community we can make it clear that by holding Veterans Day on the Hill this late we would gladly make it into a celebration if our elected officials get their work done for Veterans within the first three months of session. If they decide to keep Veteran's issues moving, and above the predictable partisan fighting, they can all enjoy a day of being cheered for a job well done.

However, if the more likely scenario happens where politicking is taking the place of progress, this later date will have us positioned to make a strong call for our officials to "Get it DONE for our Veterans" (or some better tagline).

This is Minnesota and the weather can suck earlier in the session.

Additional details will emerge as the CTF, UVLC, and MACVSO work toward their vision of the formal VDOTH proceedings. The DAV MN does intend to offer funding busses and providing a lunch prior to the formal event again this year. Details will be shared as they become available.
