## CHAPLAIN'S CORNER

During the last couple of months we have been considering some of the issues relating to reputation and the life of the prophets. The prophets' life was very difficult because often times the words they had from God to share with Israel's general public to include government officials was not welcomed. God would often warn about future changes to take place, an example of this occurred during the time prior to the exile. Yet, at the same time there were instances when things were pretty hard, and God would share a word of encouragement and hope reflecting how things would again change in the future after His people repented (or changed the way they were living). God's words were often considered by many people to be countercultural for the moment, an example of this are the things Jesus said in the Gospels (Matt 24, Mark 13, Luke 21) and The Book of Revelation. This month we will be taking a look at The Book of Revelation.

When a person looks in, or hears about The Book of Revelation, this seems to conjure up a great deal of speculation, fear, anxiety, complexity, sensationalism and "end of the world scenarios". People see Revelation as being interpreted in a number of different ways, yet it is important to understand what the meaning would have been for John's audience. The entire Book of Revelation was meant to be read and heard by the congregations or churches in Asia Minor (Rev 1-3). At that time, The Bible for John's audience would have been the Old Testament, since the New Testament was still in the process of being written and had not been completed. There is not much difference between The Book of Revelation and many other books in the Old Testament (Genesis, Zechariah, Daniel, Kings, and Isaiah). God's message really has not changed over the years, His message involves calling sin for what it really is, turning or returning back to Him, living our lives according to His purpose, and establishing a relationship with Christ. These are all the same messages throughout the scriptures (John 8:56 - 58). Jesus spoke about separation, judgment, and hell in the Gospels just as He spoke about staying connected with Him, restoration, and heaven too. Yes, we have a choice to make, this is the same choice everyone in the world has to make from Genesis to Revelation and today. This choice is making a conscious decision to give our life to Christ and experience the freedom only He can provide, while still living here on Earth. Christ is our perfect example of how to live for God, sacrificially, which is our service to God (Romans 12:1-3), for example when we make plans, we want to include God's plan for our lives (James 4:13-17); not suggesting things will be smooth, but it will be good.

So many times a person reading the Old Testament will come across scriptures where a king demands a kind of cultic worship we in this day and age do not really understand very well. Yet, there are cultures today where something like this does happen, such as in North Korea with the cultic personification of Kim Jung Un, or the total and uncompromising allegiance of past totalitarian regimes such as Rome. Jesus lived in a very oppressive society and although Rome was known for keeping the peace, it did so under an umbrella of ruthlessness. Notice Jesus' mission was to introduce the kingdom of God and not start a political, military or religious revolution. Jesus total focus was to do God's will, be an example for us to follow, while not compromising our convictions in Christ or the plan He has for our lives (Hebrews 11, 12, & 13). Our prayer is for you to know Christ and renew your mind so you can know His plan for your life.
