ADJUTANT CORNER

Minnesota Approves Historic Tax Cut for Veterans

St. Paul, MN- The Minnesota House and Senate passed a supplemental budget bill that included a provision exempting military retirement pay from state income tax. This provision was supported and championed by Representative Bob Dittmer (R-Forest Lake, MN), Chair of the Veterans Affairs Committee in the Minnesota House of Representatives.

There are close to 18,000 veterans living in Minnesota who will see their military pensions exempted from state income tax. The tax exemption also applies to survivor benefit pay, so the spouse of a deceased military retiree who receives 'survivor benefit pay' would be able to subtract that pay from taxable income. This tax exemption was the result of a nearly 20-year push in the Minnesota legislature, and I am truly grateful to those who were fighting for this exemption long before I was elected."The supplemental budget bill, which included the veterans' pension exemption, was signed into law by Governor Mark Dayton. Here I want to thank all who went to the Vets on the hill you did make a difference. Please plan to attend Vets on the hill next year our John Persil also helped with this.

Veterans ID card with photo can now be used to help register to vote.

Today the state of MN leads the Nation at 102.76 % new members and we lead the State of MN at 111.13 %, Chapter 38 Park Rapids is at 110.54 as of 6/23/2016. We are not out of woods yet, as all new memberships may not be counted! Tom Annonson has 9 new members, Sadoris 12, we have 58 new members this year.

We now have the smallest Army since before WWII, with 479,172 Solders on active duty, 1,348,463 in ANG, and 199,561 in AR. Pay raise projection for 2017, the House wants 2.1 %, while the White House wants 1.6%.

I went to DAV Convention in Lincoln Montana very good experience, we did get new member signed up in MT. Joe Parsetich 14 District rep on National Executive Committee. We left home the last week in May as I write this we are in Iowa have been in 8 states and by the time we arrive home we will have traveled over 4,000 miles. I now belong to three of our four 14th District SD, MT, and MN. I will be going to Cincinnati OH Adjutant Commander training first of July and to the Nation Convention in Atlanta Georgia last week of July.

I am much honored to represent you on both the local and State level. As your Adjutant and State Senior Vice Commander. Tom Annonson was appointed to State membership committee for 2016-2017. By our new State Commander Mick Aguirre. I expect him to be up to visit our Chapter this year. We will close on our new building July 1st 2016. May God Bless each of you and you families.

Lots of excitement this month! We had a great meeting on June 20, 2016.

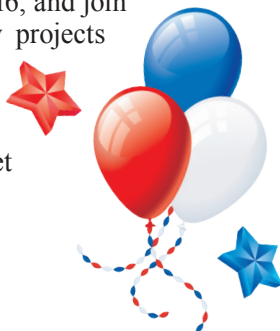

CHAPLAIN'S CORNER

A few months ago we were discussing communication and how sometimes communication during an election year (and other years too) get to be pretty intense. During this process things are written and said out of context which causes a lot of misrepresentations. Unfortunately, in like manner, the scriptures are often taken out of context because of a lack of information or understanding. One example is the flow of Genesis in the beginning regarding Adam, Eve, Cain, Able and Cain's wife (Genesis 4). Many people will use this exact situation in a manner to prove the Bible is inaccurate, which is really sad, often creates problems for young believers (those who recently put their trust in Christ for living throughout eternity).

There are several things going on at the same time when it comes to Adam, Eve, Cain, Able and Cain's wife. Often times we focus on Cain and Able regarding their worship, attitude and relationship to each other (Genesis 4). Many people are surprised to read about Cain's wife (Gen 4:17) at this point in the scriptures because the scriptures never mention him getting married. Up to this point in the scriptures there was only Adam, Eve, Cain and Able with no mention of any daughters being born. This is where many people are not following the context of the story.

This story is about salvation, God inspired Moses to write about this to show us exactly the things we needed to know about God and His plans to create a people for Himself. This story was written by Moses during ancient times, so our current western way of thought and writing is not present. We have to put ourselves in the culture of the time the scriptures were written.

Adam and Eve had daughters, since Adam and Eve were the first humans. There are many things The Bible does not mention, one of those things is time regarding the events of Genesis 3-4. The Bible does not say how long Adam and Eve were in the Garden of Eden, nor does it say how long they were out of the Garden of Eden before they had Cain and Able. Yet, it does mention one of the curses of the fall for Eve was pain during birth (Genesis 3:16). We understand Cain had a wife, so she must have been born before Genesis 4:17, which means she could have been born either in the Garden of Eden or after Adam and Eve were expelled. One indicator regarding this issue may be when God informs Eve she will experience pain when giving birth, in other words - up to this point, she had not experienced pain. We certainly do not want to speculate, yet it seems probable, and the question becomes could Eve have given birth to daughters in the Garden of Eden? There is another consideration from this too. Look at Eve's statement after she and Adam were expelled, Eve gives birth to Cain and says "I have gotten a man from the Lord" (Gen 4:1). This being the case it very well may be this is the first son she had given birth with prior children being daughters (at least one - Cain's wife).

Again, all this to reflect the fact scriptures are very enlightening when a person looks at it carefully. There were many years' people asked where Cain's wife came from and unfortunately it was not possible to know at the time, until years later. Yet, not knowing something is a far cry from not trusting The Bible and not trusting God. God does want to share His love for all people. He wants so much to draw all people to Himself, repent and trust in Christ.
