ADJUTANT CORNER

Just back from National DAV Convention in Atlanta, GA. We should all go if possible; it is an outstanding teaching tool go to (dav.org) pull up all the different subjects from Convention.

We just received a new Transport Van seats 9 plus driver! I am not sure you all know how we get DAV Vans throughout state of Minnesota; State DAV Foundation gets a grant from National DAV and adds money to it and buys the new vans, some Chapters give \$10,000 to help purchase a new van and State DAV Foundations gives the rest. In our case it was free for third time this may not be the case in future. After DAV owns van it gives it to the VA in our case Fargo who then issues it out to the Chapter to use, so the vans do not belong to any Chapter or the DAV they belong to the VA hospital; thus all Gas, any maintenance, and insurance is covered by the VA. Chapter provides drivers who need not be DAV members, can be anyone; then VA at Fargo does background checks on drivers and gives them training. It is my job then to make schedules and ask drivers to drive the days we run to Fargo. Any time you have an appointment if you go to our web site look at news letter you will find the days we go to Fargo tell the scheduler in Fargo you use Bemidji Van, they will schedule your next appointment to fit our schedule. Every scheduler at Fargo VA has a copy of our schedule. No cost to you to ride with us. If we had more drivers we might be able to go two times a week instead of one. Our old van went to Wheaton where Fergus Falls Chapter gave \$10,000 to have it placed there.

If you have not seen your new building thus far you should go see it at the east end of 15th street the clothing workers and several of our Chapter members have really done a bang up job on it. We are working on the details of the Stand Down this year and will keep everyone updated.

Lots of room to go down to see the Medal of Honor awardees we plan to take bus down at no cost to you, call Tom Annonson for details.

I would encourage each of you to recruit a new member; carry a membership application in your wallet, we all know someone who could be a member let's get them signed up call Annonson or Sadoris for applications, if you do not have one. There are close to 39,000 Veterans in our counties we should have 5,000 members not 560 the cost is very small as the price is \$100 less then stated price on the application, the more members, the more bills we can get passed for all Veterans. Plus the Chapter gets \$3.50 each year for each of its members.

Fall Conference is in Willmar October 7th & 8th it will be for helping us learn about how the DAV operates plus lots of valuable information. The District 14th Conference will be at Fargo October 22nd. Our new 14th District rep is Past State Commander David Valtinson thus he will be on the National Executive committee. There are 21 Districts in the DAV ours includes SD, ND, MT and MN. Our past State Commander Greg Remus was awarded a watch because we were first in our District also awarded a trophy because we were first in Nation for new members. We are second to Park Rapids at this time Mr. Annonson did get 7 new members at County fair, and Sadoris has 4 new members not counted by National yet. We are wanting more Female Veterans they are hard to spot as they do not usually wear the hats like their male counterparts; here is where each of you come in as you may know one or more; we also need hundreds of Male Veterans please help. You would be very surprised to find out once you tell folks our only mission is to help Disabled Veterans or their Spouses if they are deceased, that we have no other purpose as an organization. How fast they will become a member. God Bless each of you and you're Families.

MEDAL OF HONOR RECOGNITION CEREMONY

On Wednesday **October 5, 2016** from 10:00 am – 4 PM at the US Bank Stadium (Vikings Field) 1010 S 7th St. Minneapolis there will be an open house and autograph signing by the current surviving Medal of Honor winners. This is a rare chance to meet all of the surviving Medal of Honor winners at one time. Of the 76 living recipients, 6 earned their Medals of Honor in World War II, 6 in the Korean War, 53 in the Vietnam War, and 11 in the War in Afghanistan. **3** earned their medal while serving in the U.S. Air Force, 50 in the U.S. Army, 15 in the U.S. Marine Corps, and 8 in the U.S. Navy.

CHAPLAIN'S CORNER

Last month's article was about baptism, what it meant to Jesus and what it means to us. Jesus was identifying with our humanity in His baptism, while for us it means a being renewed into a new life through the change in the direction of our lives as well as having a refreshing time in God's presence. This is something that only God can provide to us through the Holy Spirit living within us as we respond to him in obedience. In short, baptism is so much more than a simple ritual, it actually is a means of keeping God's covenant.

Another facet of our lives comes in the form of a statement made by a person who said the counseling needs of people includes forgiveness and love. All through the scripture we read about God extending His love and forgiveness to the world (people who do not know Him), but to His own people too, even though, at times, we have disappointed Him. There are many examples (Exodus 32, Jonah 1, John 3). This does not mean we understand everything there is to know about God or why He does something in one particular situation in contrast with another situation or His character. Some of the things written in The Bible God has done seems counter intuitive to some of our own ways of thinking and our Christian culture. An example of this is lying, we all know God hates lies (in the political correct culture that means misspoke or misrepresent especially when attitudes and personalities are involved), yet we read about a spirit of a lie being dispatched by God against false prophets (I Kings 22:22). What does this mean when we do not understand it? Do we accuse God? Do we throw away our faith as if throwing in the towel?. Absolutely not. The lack of understanding is on our part, but what we can do is continue to trust in God, knowing His love and forgiveness is still for us, recalling Job's patience (James 5:11).

Months ago we also dealt with some hard areas of the scriptures too, regarding judgment and the seemingly lack of mercy, as we saw back then, there is so much more to the story than what often is apparent. There are other issues that need to be considered such as context, language, the meaning of the scripture, the big picture, God's intent, the future consequences of an event (Romans 8:28-39) and the things God has in store for His people (James 5:11). Yet in all of this God can still be trusted with His love for us, regardless of our experiences on earth.

It is understood in our culture that if you are not successful in something, then you have failed. There are many different ways to define this failure just as there are varying ways to define success, it really is, in some cases, very subjective terms. Yet in other instances there are definite definitions with specific legal ramifications. Those who are really successful are placed into a "Hall of Fame" or given title of "Hero." This is certainly not to take away from their accomplishments or the appreciation of the many who have sacrificed so much, yet for those whom things have not worked out as expected - a failure identified by our culture, government agency, or individual does not necessarily mean a person has failed according to God. Hebrews 11 mentions all those whose accomplishments were exceptional by trusting God, but it also mentions those whom our culture would have considered to be legally a failure (Heb 11:36-40). There are many ways in which our culture may consider something a failure, but it is not a failure from God's perspective. Through God's help it is possible to recover and in those cases when it is not (Luke 23:39-43), we still have hope through our relationship with Christ, just as the criminal did dieing next to Christ. Yet, Jesus was dieing separate and alone from God. Hope this helps as we all wait for Christ's return. Jesus identifies with our humanity.

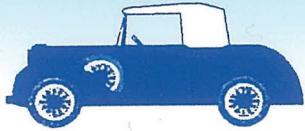

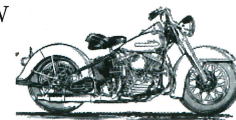
