Folks I have tried to include news events that you may be interest in. As I write this, MN is second in nation to SD in membership; MN needs 107 new members to reach goal SD needs 20 new members to reach goal, we have 8 Chapters in the State that have reached goal, and we are one of them. We have sent in at least 9 new memberships that have not been counted yet. Please carry a membership application with you and sign up just one new member. If you each do this, we will be first in State and once again have Chapter # 7 on award board at the State DAV office. All so, for every member you sign up, you will get \$2 off items at DAV Stores.

You should each come see your new building, the crew has done a great job with it. Our meetings will be held there now for the next few months. Also we have a new Van and our wonderful drivers are willing to make two trips a week to Fargo, (see the New schedule in this newsletter). We can always use more drivers, so if you know someone who would be willing, they do not need to be Veteran to drive. Call Saddoris for details. Also very important the Van can only be used to take Veterans to the Fargo VA Hospital, and it can go to other hospitals if Veteran has a referral there, but cannot take Veterans to any other locations without papers from their Doctor or the VA scheduler. We have one driver with over 500 hours, Billy Ayers, please thank him when you see him. I am so very proud of our drivers, they are outstanding. Tell your doctor you ride the DAV van and they will schedule your appointments to coincide with it.

I am also very proud of Our Treasurer she does such an outstanding job as well! How very blessed this Chapter is to have the Volunteers, both DAV and Civilian, that work so hard for us each day.

President Barack Obama on Wednesday set the military pay raise at 1.6 percent for next year. The figure is higher than the 1 percent increase he approved for civilian employees in the federal government but lower than the 2.1 percent bump service members are supposed to receive under the formula in current law. The change to monthly basic pay will take effect Jan. 1 and marks the fourth straight year troops will see their pay raise fall short of private sector-wage growth.

Stars and Stripes reports that a new study, which is about to begin accepting participants, will assess the safety and efficacy of four types of smoked marijuana to manage chronic, treatment-resistant post-traumatic stress disorder (PTSD) symptoms. In the first phase, 76 participants will smoke randomly assigned types of marijuana, including a placebo strain, from a pipe for three weeks. They will then abstain from smoking for two weeks. The second phase is a repeat of the first. Afterward, participants will follow up with the researchers for six months. The study should run about two years. Those interested in participating in the study in the Phoenix area can email arizona@marjuanasites.org.

The Department of Veterans Affairs (VA) is partnering with Women Veterans Interactive (WVI) to launch a State of Women Veterans' social media campaign. The goal of the campaign is to raise awareness of women veterans' military and societal contributions and provide an avenue for informing women veterans about the VA benefits they have earned. The campaign will conclude over the Veterans Day weekend and will be recognized and featured during a WVI-sponsored event in November. CHAPLAIN'S CORNER

Over the last several months we have been exploring the process of communication while making some observations in light of the scriptures. The foundation of this topic for the year is the attributing effects we here in the media in light of this election cycle. It seems the world we live in (the here and now) seems to always bring to mind the reality of the scriptures for the other world (the eternal) we live in too (Ecclesiastes 3:11). Over the course of this year we explored other topics as well yet again, there is an overwhelming desire to visit the Book of Genesis regarding this subject of communication although The Book of Proverbs has a lot to say about communication.

As you may recall in our June 2016 article we looked at Adam, Eve, Cain and Able, while at the same time pointing out observations regarding the reliability and truthfulness of the scriptures. This occurs even when the issues are not readily apparent. Keeping this in mind, let's take a look at Eve and some of the things God said to Satan.

First, let us consider Eve (poor Eve). It is astounding to hear the extent to which Eve gets the blamed for sin coming into the world. Even today, the climate in our culture so often supports conversations (and gossip) regarding gender inequality (so evident in the media and elsewhere), which is truly amazing especially when one looks at Genesis 3. It seems our culture is always supporting the same level of blame for women, which Adam blames Eve. Yet if one looks at the scriptures, three undeniable and specific observations regarding this issue can be made. First, Adam was with Eve at the time she disobeys God (Genesis 3:6). Second of all it was Adam (not Eve) whom God instructs '...of The Tree of Knowledge of Good and Evil, thou shall not eat...' (Genesis 2:17), as a matter of fact, at the time God gave these instructions to Adam, Eve did not even exist! The third observation is the fact scriptures are clear - it is through man - Adam - (not Eve) sin enters the world (Romans 5:12, KJV). Essentially it was Adam who was responsible for protecting both his wife and the Garden of Eden from Satan. The question becomes how would Adam protect Eve and the Garden of Eden? He would have done so in the same manner Jesus Christ did (Matt 4:10, Luke 4:12) and in the same way we are today (Ephesians 6:13-14, James 4:7). Thoughts to consider the next time we hear the attitudes from our culture trying to give Eve (and women) a bad name!

The other issue is the statement God made to Satan referring to Satan's seed and Eve's seed. Notice Adam's seed is never mention. Many scholars view Genesis 3:15 as a prophetic allusion to the Messiah, (essentially looking back from our vantage point) where Satan will bruise Jesus heal, but Jesus will crush Satan's head. We often see where Jesus Christ is definitely from the seed of the woman, scholars often mention Adam could not be a part of this because it was through him (Adam) sin entered the world, hence Jesus Christ will be conceived through the Holy Spirit in the virgin birth by Mary (Luke 1:31-35). Yet, what about the seed of Satan? Who could this be? One observation is the origin of the Giants (Genesis 6:1-6, Jude), and consequently the continuation of those Giants such as Goliath, his brother. This includes all those who would oppose God into the future (1 John 2:18-22). It sounds like we are back into discussing the reality of the spiritual conflict, which has always been so evident around us and a part of our world (here, now and into the future). 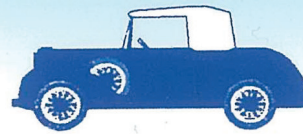

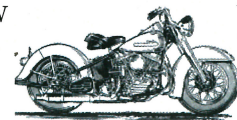
