CHAPLAIN'S CORNER

Hi family members, auxiliary, comrades and everyone coming to visit this article. As I carefully pondered writing this article, my thoughts consider picking up our conversation from last month, and the general theme over the past 12 months. This is not something I planned out or put together the last moment, rather it is a chance to look back at all the articles written. So far we have considered; life here and now, future events on earth, God's Kingdom, life after we pass away, heartaches, regrets, false information about Christ, false evangelists / teachers, condition of our hearts as enemies of God prior to living for Christ, current misuse - misrepresentations of scripture, reality, hardship, faith, hope, and friendship. This includes the value of our commitment to live right for God and country, while sharing our experiences in or out of the military.
