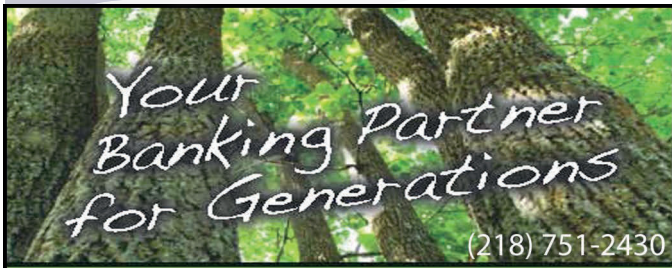

F. Communications: Two pieces of correspondence to report. The Senior Center sent a thank you letter for the \$2,000 donation from Chapter 7. A letter from Josh informing us of the latest status of the clothing program was received indicating things are about the same as last month.

G. Committee Reports:

2. Service Officer: Nothing to report.
3. Hospital/Sickness & Distress: Mike Gutz was hospitalized following a motorcycle accident and is now recovering at home.

## CHAPLAIN'S CORNER

There isn't a human being alive on this planet who isn't acquainted with troubles. Times of difficulty arrive unexpectedly, often remain indefinitely, and the sorrowful memories they produce take deep root in the mind. It is no wonder, then, why Jesus' promise in John 16:33 also takes deep root in the minds and hearts of so many Christians today: "In this world you will have trouble. But take heart! I have overcome the world."

This comforting verse is found within a larger section in the Gospel of John. Chapters 13-17 make up what scholars refer to as the "Farewell Discourse". These are Jesus' final words of reassurance, comfort, and encouragement to his disciples in the upper room before his betrayal, arrest, and crucifixion.

In John 16, He speaks to them of His impending death and departure, as well as their desertion. In John 16:32, Jesus tells them, "A time is coming and in fact has come when you will be scattered, each to your own home. You will leave me all alone. Yet I am not alone, for my Father is with me." Certainly, this was not something the disciples wanted to hear, which is why Jesus immediately followed up with his comforting words in John 16:33, "I have told you these things, so that in me you may have peace. In this world you will have trouble, but take heart! I have overcome the world."

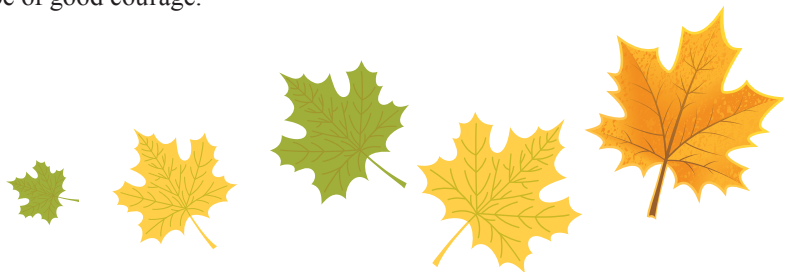
In this verse, we see two certain realities: 1) the followers of Jesus will suffer great distress, and 2) Jesus has already won the victory. He didn't want his disciples to be under the delusion that their future ministry would be full of ease and comfort, nor did he want his disciples to think the future is hopeless, and he doesn't want us to think that either. Following Christ is difficult and there will be opposition. Yet, the reality of Christ's victory over sin and death via his own death and resurrection provides peace and courage in the midst of that opposition.

The specific phrase, "Take Heart, I Have Overcome the World," is found in both the New International Version (NIV) and the English Standard Version (ESV). Other English versions render it slightly differently. "Take Heart" (Greek: tharseite) can also be rendered as "take courage" New American Standard Bible (NASB) or "be courageous" Christian Standard Bible (CSB). The classic rendering of the King James Version (KJV) is "be of good cheer." The word "overcome" (Greek: nenikeika) could also be translated "conquered" New Revised Standard Version (NRSV).

Jesus' claim of victory over the world is in reference to his death, burial, and resurrection. Earlier, in John 12:31, Jesus stated that his crucifixion would conquer and cast out the "ruler of this world." Elsewhere, Hebrews 2:14-15 states Jesus came to earth "so that by his death he might break the power of him who holds the power of death—that is, the devil—and free those who all their lives were held in slavery by their fear of death." The finished work of Christ removes the teeth from suffering. By entering into our world and suffering alongside of us, Jesus offers certain hope that transcends the temporal sorrow and suffering this world throws at his followers.

Therefore, we are not called to overcome the world ourselves because Jesus already did. He provides his children with a certain future — a "living hope through the resurrection of Jesus Christ from the dead" and "an inheritance that can never perish, spoil or fade" (2 Peter 1:3-4). It is because of this reality that we can "take heart" and "be of good courage."

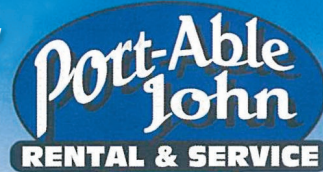
