CHAPLAIN'S CORNER

Last month we were in-part looking at a mystery (the period of time we are living in now). Jesus Christ described this mysterious last two thousand years in this way, "... and Jerusalem will be trodden down by the Gentiles until the times of the Gentiles be fulfilled (completed)" (Luke 21:24; cross reference to Isaiah 63:18 and Daniel 8:13) - Amplified Bible. Jesus stated the event that would usher in this portion of history from God, saving humanity (salvation history), is the destruction of Jerusalem and the Temple, which occurred in 70 AD, thirteen years after Paul wrote his letter to the Romans. This would be a time, and still is, when God's presence moves from the Temple in Jerusalem into the hearts of all who have given their lives to Christ. Paul further mentions that the length of this time frame of Jewish history would be however long it takes to bring, or usher in, the salvation of Gentiles. This includes all of us outside of Israel, through Christ's work on the cross (Romans 11:25).

It's interesting to note this period of Jewish history we are currently living in, or experiencing now, is a mystery written by Paul (Romans 11). While Paul was writing about this mystery of salvation history (Romans 11:25), he also included the graciousness of God and a very severe warning of immense importance to all of us Gentiles, to include Palestinian Christians, Messianic Jewish Christians and all believers. We are to be very careful about our own attitude towards the Jewish People (Romans 11:20-29), as well as the temptation we may have to brag about being saved. A person may ask, to whom would Christian's brag? The answer is - to the Jewish people. The Jewish people have been so hurt by Christians and those purporting themselves as Christians throughout history in a way that it's just terrible. We have a tremendous respect and admiration for the Jewish people and always will, while taking to heart Paul's warning to us all. As mentioned in last month's article, there is absolutely no room for an attitude of anti-Semitism in the heart of a Christian as we continue to see all over the place through the media. As Christians we are in-fact, according to God's view, Jewish people (Romans 2:29) and through the mystery of His providence, grafted into Israel (Romans 11).

We see here that the Jewish people were chosen by God and entrusted with the most sacred of duties, to preserve His land and oracles. Despite all of their hardships, they remain steadfast. I hope this encourages all people from all walks of life to follow the example of Abraham, Isaac, Jacob, Elijah and to know Jesus Christ.

We started this article by looking at one of God's mysteries. There are other mysteries we would like to discuss in upcoming articles. This is not to say we are going to be able to solve these mysteries. In many instances we can discuss mysteries, but nevertheless, after our discussion, the mystery is still a mystery. Some mysteries exist in history, such as the entire time throughout the Old Testament (thousands of years) - salvation through Christ's work on the cross. Another example can be put forth in the form of a question for today, why does God allow so much evil to exist in the world? This is called the mystery of iniquity. God also has a timeline with mysteries still in the future. For now, let us keep praying, "...under God's mighty hand, that he may lift you up in due time. Cast all your anxiety on him because he cares for you" (1 Peter 5:6 & 7, King James Version).
