CHAPLAIN'S CORNER

Greetings to all you Disabled American Veterans, Auxiliary Members, Citizens, Fellow Americans, Moms, Dads, Friends, and Neighbors. Last month we were discussing some of the mysteries in The Bible. We concluded these mysteries are not necessarily something we are looking to solve, but rather we want to know more about the mystery itself. The mysteries we will be looking at are those specifically identified by the scriptures as hidden truth in the past, present and future. Some examples of mysteries in the past from the Old Testament were the mystery of God (Colossians 2:2), Jesus Christ (Colossians 4:3), and The Gospel (good news of God saving all who believe in Christ - Ephesians 6:19). One may ask the question, "How did the Old Testament refer to Christ, when He had not been, born, named, or known back during that time?" The Old Testament referred to Jesus Christ by many names, Lord's Servant, Son of Man, My Lord, A Prophet Like Moses, and described the purpose for Him being here on Earth, as well as the things that would happen to Him such as His crucifixion (Isaiah 53, Daniel 7, Psalm 110, John 4, Luke 24:44, Deuteronomy 18:15-19). Yet Christ was definitely a mystery throughout The Old Testament, or Tanakh (Jewish Bible) because many people did not fully understand Him through all the prophetic indicators. There was confusion between two different Messiahs, one would be a suffering servant, while the other a victorious king. Yet somehow, out of these two, a Messiah would make everything right for Israel. The Samaritan woman and her town's people met Jesus Christ, and then, they understood this mystery, or hidden truth. (John 4).

God, from out of His love and kindness gave people a way of being with Him in peace, forgiving their sins and iniquity on credit such as Job (Job 1:8). Therefore, when Jesus Christ did arrive on earth to do everything The Father wanted Him to do, Jesus paid off the credit through His work on the cross and became a bridge between the holiness of God and the iniquity of all mankind (past, present and future). God is so incredibly pure and holy; He cannot see or be in the presence of evil (Habakkuk 1:13). Man on the other hand is so incredibly evil in comparison to God. The presence of evil automatically incurs God's judgment and punishment, yet at the same time God's love for all of us is such that God wants everyone to be saved (1 Timothy 2:3-4, Ezekiel 18:23, 2 Peter 3:9, Matthew 23:37). It is through God's kindness that draws us to Him so we can change our mind and follow Him, while asking God for His forgiveness of our sins (Romans 2:1-11). There are a lot of people who have difficulty balancing these two extremes, but this is where Jesus Christ (fully God and fully man) comes in to resolve this dilemma through His work on the cross. God knew from the beginning, all of this was going to take place, and this is why Christ was slain from the beginning of creation (Genesis 1:1, Revelation 13:8). The cross is actually the location where God's purity and man's iniquity literally collide, and among other things, allowing Gentiles to be part of Israel (Romans 11), thereby making Jewish people jealous because we honor and believe God by using Jewish customs. This can be seen by Christians who participate in Passover meals and respect the Jewish people.

In the next few months, we will be looking at the mystery of iniquity (2 Thessalonians 2:7) and the mystery of all believers being changed (translated) in the future and caught up in the sky to be with Christ forever (Rapture - 1 Corinthians 15:51, 1 Thessalonians 4:16). We will be attempting to answer a military retired veteran's question regarding God's pre-ordained plans and mankind's free will.
