CHAPLAIN'S CORNER

This month we continue with our discussion about Ephesians. As veterans and auxiliary members we are acutely aware of our on-going and current changes to our society in our country. We would like to discuss two particular issues that seem to always be a part of our society in one form or another - death and disunity. No matter what era we are discussing, from Vietnam to the global war on terrorism, these two issues are always apart of our lives. This is particularly true now as we mourn for the assassination of Charlie Kirk and pray for his family.

We can see Apostle Paul writing about the same thing in Ephesians 2:1-10 - death and disunity. Yet he also mentions a solution to both of these, God's grace to save us (Eph 2:5) and his purpose to bring everyone (Jews and Gentiles) together in Christ. Essentially it is God who has taken the initiative to sacrifice everything in order to get us out of this mess.

We can see in Genesis where God warns Adam about the consequences of disobedience (sin) is death. It is through the disobedience of Adam (not Eve) that death has been apart of all our lives (Romans 5:12). This is a terrible tragedy, something we can not control that creates havoc in all our lives and families. Yet we can see God, through grace, using death as more of a transition than an incredibly worse situation (Genesis 3:22). Can you imagine what it would be like living eternally under the same conditions of Nazi Germany, 1941-1945 (Genesis 6:5-8)? God made sure we would not live forever in a terrible condition by making sure Adam did not eat from the Tree of Life after he disobeyed God (Genesis 3:23 -24). Another example of God's grace is taking care of Noah through the flood (Genesis 6:8), instead of "[God] destroy man, whom I have created, from the face of the earth" (Genesis 6:7 - King James Bible). As a result of all this history in the Old Testament (Bible used by everyone during Paul's life) it is imperative for Paul to ensure the Ephesians understand God's grace; "But God, being rich in mercy because of his great love with which he loved us, even when we were dead in our transgressions, made us alive together with Christ (by grace you are saved)." The two questions now are, what is and isn't grace?

As demonstrated by God above, his grace is favor and love people towards people who don't deserve it. God favors and loves inmates, fugitives, those dishonorably discharged and anyone who has done wrong as listed in Galatians 5:19-21, I Corinthians 6: 9-11 and given their lives over to Christ. It is so wonderful the kindness of God draws people to Christ and motivates them to change their life. As a result they are totally cleaned from the inside out and free to live the rest of their lives as part of God's purpose to point others to Christ.

There are some misconceptions about grace as well. Unfortunately these misconceptions can really cause havoc in a person's mind by the manner they view God. This is why it is so important to continually grow in the knowledge and grace of Jesus Christ, which leads to a person having a peaceful heart (II Peter 3:18; II Peter 1:2). As a result other verses like Colossians 2:2 and Titus 2:11 emphasize the importance of understanding God's mysteries and godly living (not religion) that yields this knowledge. This brings us all the way back to our first article in July 2025 regarding the mysteries of God in the person, life and work of Christ (Ephesians 1:9-11).





To stay informed and take action to support federal legislation and policies affecting veterans, their families and survivors, please join DAV CAN (Commander's Action Network).

To enroll, go to the DAV.org website and do a search for the "Commander's Action Network" it will direct you to a results page and there you will find the link to sign up and become an active participant in the program. Once you are enrolled you will periodically receive emails with "canned" letters to your individual representatives on legislative matters pertaining to veterans' issues that are currently before them in Congress encouraging them to act on behalf of all veterans that the proposed bill in question is addressing. Simply click the "take action" button at the bottom of the email and the letter will automatically be sent.



VA: SWITCH FROM DS LOGON TO LOGIN.GOV OR ID.ME BY SEPTEMBER 30

After Sept. 30, 2025, Veterans will have two secure options to sign in to VA.gov and VA mobile apps—a Login.gov account or ID.me account. Most Veterans have already made the switch. If you're still using a DS Logon username and password, we want to make sure you're prepared when this option is discontinued by the end of September.

How to Transition

- 1. Visit Creating an account for VA.gov for detailed instructions on setting up your Login.gov or ID.me account.
- 2. Follow the step-by-step guide to create your account and verify your identity.
- 3. Use your new account to access VA services online as you did before.

What this means for you


- Submit mileage-only travel reimbursement claims for VA-approved health care appointments using the VA Health and benefits mobile app.

VA: IMPORTANCE OF MAINTAINING YOUR VAID CARD

As a Veteran receiving health care, one of the most crucial assets you possess is your VA ID card. It's imperative to understand why maintaining and updating your VA ID card is essential and how you can ensure it remains functional.

Identification at VA Facilities

Your VA ID card serves as your primary identification at VA facilities. Whether you're seeking medical care, accessing benefits, or attending appointments, this card is vital. It streamlines the identification process, reducing potential human errors and allowing seamless access to your personal files and medical records.

Check-in for Appointments

When you have appointments at VA facilities, your VA ID card is a necessity for check-in. It helps staff quickly verify your identity, ensuring a smooth and efficient process.

Updating Your VA ID Card

If you need to update your VA ID card, visit the enrollment office at your local VA facility. No appointment is necessary for this process. The staff at the enrollment office are there to assist you in updating your information. Don't hesitate to ask any VA employee for guidance or assistance. They are more than willing to help you navigate the process of updating or obtaining a new VA ID card.

Inspecting Your VA ID Card for Serviceability

Image Accuracy

Ensure that the photo on your card accurately reflects your current appearance. If not, it might be time for an update.

Expiration Check

Regularly check the expiration date on your VA ID card. An expired card might hinder your access to services and benefits. If your card has expired or is about to, it's crucial to visit the enrollment office for renewal.

Ensuring Barcode and Card Information Accuracy

Your VA ID card's barcode and information play a pivotal role in swiftly accessing the benefits and services you're entitled to as a veteran. Regularly inspecting and ensuring the integrity of these components is essential for a hassle-free experience when utilizing your card at VA facilities. If you notice any issues with the barcode, information accuracy, or physical wear on the card, promptly address them by seeking a replacement or an update at your nearest VA enrollment office.


