CHAPLAIN'S CORNER

Last month we took a break from discussing The Book of Ephesians in order to reflect on the Pearl Harbor attack, World War II, in relation to scriptures. If we may, we would like to add a few more observations to our article last month. It is interesting to note that the very first war to ever take place was a long time ago, in a place far, far away - heaven (Isaiah 14, Ezekiel 28, and Revelation 12). Another interesting observation is the rebirth of Israel, specifically as a Jewish nation from out of the ruins and ashes of the Holocaust described in scripture (Ezekiel 37). Granted, there are a variety of different views by people regarding these observations and the corresponding relationship to scriptures. The different views held by others are beyond the scope of this article, yet these scriptures, and the corresponding events have been a subject of past controversies.

Since this is the first article of the year, we would like to take another small break from our exploration in The Book of Ephesians and cover a popular but misunderstood verse. Yes, there are many other misunderstood verses in The Bible, yet this particular verse caught my attention this month. Allow us to mention a little something about the exploration of misunderstood Bible verses. Having questions and researching scriptures is actually a wonderful way to spend time with God. Misunderstanding scripture is a great way to start on a journey and find a little gold nugget we can keep. Allow us to give you an easy way to misunderstand an idea using common English words - NOWHERE. We know this is a typographical error, but what about that part of the story the original author was intending to write? There are two possibilities, NO WHERE or NOW HERE. As a result, the reader would need to understand the context of the passage in order to understand that particular sentence. As a result, this is where research is helpful. So, let's get started, NOWHERE is the verse (Matthew 7:1).

Many people consider this verse to simply mean we are not to judge others. This idea alone can open up our families to poor, unproductive, and in some cases dangerous relationships. Yet the context of the entire passage means something totally different. Jesus is simply stating a well known fact for anybody - not to be a hypocrite. Jesus simply wants to protect a person from being wrongfully judged, because we all know the cruelty that comes from others when judging hypocrites - nobody like to be judged in this manner.

Many people believe not judging others while being inclusive is the best way to handle relationships. We saw this in the free love movement of the 1960s and we now see it in our "Woke" Diversity, Equity and Inclusion (DEI) culture. Yet we still need to protect ourselves from unwanted, cruel and controlling relationships - something we can do for our families this year. Some really good verses that can help us out are John 7:24, Proverbs 31:9, II Timothy 3, I Corinthians 5:9 - 13, and III John 9-10.

Our prayer for you this year is to enjoy good, safe and protective relationships with all your families. In the mean time, if there is something we can do for you, please call.

After Sept. 30, 2025, Veterans will have two secure options to sign in to VA.gov and VA mobile apps—a Login.gov account or ID.me account. Most Veterans have already made the switch. If you're still using a DS Logon username and password, we want to make sure you're prepared when this option is discontinued by the end of September.

How to Transition

2. Follow the step-by-step guide to create your account and verify your identity.
3. Use your new account to access VA services online as you did before.






