CHAPLAIN'S CORNER

Last month we were looking at Ephesians 1:4-14, the spiritual blessings of Christ. This consists of: a correct doctrine, recognizing our true condition (compared to God and not anyone else), forgiveness of our sins, a life devoted to God, grace (God giving us His unmerited favor we don't deserve) and an inheritance upon our passing away. We will continue to look at God's mysterious plan and purpose. The freedom we have in Christ, as well as the application of this truth in lives today as a constant source of hope (Romans 8:28-39).

There were several mysteries God revealed to the people of the first century through Christ: a correct understanding of the Old Testament (Luke 24:44-48), God sharing and showing His people the way to live forever with Him - first to the Jews then to the Gentiles, including the Gentiles as part of God's plan, our bodily resurrection after we pass away (Matthew 27:52-54, 1 Corinthians 15:51-58), being caught up with Jesus in the clouds (1 Thessalonians 4:14-18) to be with Christ forever. Some of these mysteries were either revealed at Jesus' death, or resurrection such as dead people coming out of their graves fully alive, then going into Jerusalem (Matthew 27:52-54). There were other mysteries Christ revealed to Paul, who wrote about being caught-up in the clouds to be with Christ forever (1 Thessalonians 4:14-18)

All of these mysteries are a part of God's purpose, which is to create a people for Himself and restore harmony to all creation through Christ's work on the cross. Thereby bringing everything (heaven, hell, earth, sky, universe, spiritual, material) all under the governance of Christ. This is the reason for the importance of the term Gospel of Christ, which involves a person being born again (John 3) and living by God's unmerited favor (grace), through the hope, trust and evidence of the many things promised, but not seen (faith) through Jesus Christ (Hebrews 11). As a result, the verse in Romans 8:28-29:

- "And we know that all things work together for good to them that love God, to them who are called according to his purpose. For whom he did foreknow, he also did predestinate to be conformed to the image of his Son, that he might be the firstborn among many brethren" (King James Version)
- "And we know [with great confidence] that God [who is deeply concerned about us] causes all things to work together [as a plan] for good for those who love God, to those who are called according to His plan and purpose. For those whom He foreknew [and loved and chose beforehand], He also predestined to be conformed to the image of His Son [and ultimately share in His complete sanctification], so that He would be the firstborn [the most beloved and honored] among many believers." (Amplified).

means God makes everything to work out good for those who have given their lives to Christ no matter current circumstances here on earth, or past personal experiences. This does not mean we may see things work out for good here on earth, but in the end, considering all of eternity, even after we pass away, God will make everything work out for those who truly trust in Christ, two examples of this are those mentioned in (Hebrews 11:32-40), and the criminal alongside Jesus on the cross (Luke 23:40-43).

As part of God's plan, in the meantime on earth we continue to do the good things God wants us to do through Jesus Christ since the creation of the world (Ephesians 2:10). This is truly a wonderful assignment from God. Just imagine the freedom, confidence and rest we have in Christ to do good here and now on earth.
