Hello Fellow Veterans,

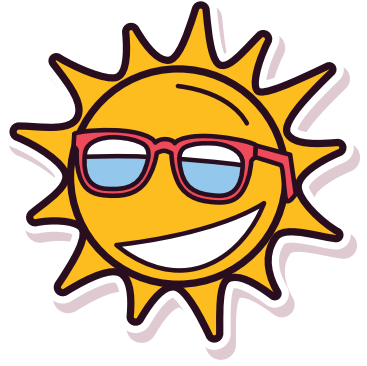

On May 19th at 0930 hrs. Kevin Gish, the Director of the Bemidji Veterans Home, gave an update briefing on how things are progressing. Currently they are anticipating the completion of construction of the building in the latter portion of this summer. This will be followed up by attaining the Certificate of Occupancy in mid fall and then having the Initial Admissions begin after achieving that approval. The timing of all these things, of course, hinges on any unforeseen delays during the final phases of Construction.
